Alex made a motion to suspend the Pledge of Allegiance and any prior meeting minutes. Fleshman seconded the motion. A vote was taken: Horn, yes; Alex, yes; Fleshman, yes. The motion passed.

#### Resolution 20-051

BE IT RESOLVED by the Board of Trustees of Franklin Township, Franklin County, Ohio, that the Board approves that only essential employees only will attend Township meetings and that all meeting will be made available to the public via Facebook live on social media.

### Resolution 20-052

Horn expressed his concern about the current temporary staff member performing the duties of Administrative Assistant during this crisis. Potts said he took advice from the Township attorney concerning this matter and a contractual worker can be handled the same as a permanent employee during this crisis. Potts said there are three primary reasons why the public needs to do business at the Township. Potts explained the following:

Horn said he is not happy with what he is hearing related to maintaining a contractual worker during the crisis. Fleshman said, the Township must have someone available to serve the public and the contractual worker is scheduled to do these tasks. Assistant Chief Adams commented that he placed signs on each fire house prohibiting interaction with the public specifically at the fire house. The Administrative Assistant can perform her duties without personto-person contact during this crisis, Adams suggested.

Fleshman agreed the public can be served effectively via telephone and email during this crisis. Horn said he would agree with this arrangement for a two-week period. Alex said he is going with the recommendations of the Governor DeWine and we have to plan for this crisis to be impactful for months.

The Police Department will only be handling necessary calls to lessen the officer's exposure to the COVID-19, said Smith.

Necessary staff are listed as: Three Board of Trustees, Township Administrator, and one (1) representative from the Fiscal Department to take minutes, unless otherwise needed.

### **Fiscal Department Report:**

Lisa Morris, Fiscal Officer reported that the Fiscal Department will begin working from home on March 17, 2020, and will only report to the office on a as needed basis during the COVID-19 crisis.

Chief Adams asked the Board what necessary steps can be taken to assisting with temporary housing for any firefighters who may be exposed to COVID-19 such as reserving a hotel room. Fleshman recommended preparing the white house (property at 1963 Harrisburg Pike) for such action if an exposure situation should occur.
