The special meeting continued with Trustee Fleshman sharing his confirmation with Assistant Fire Chief Adams, that indeed one (1) Class A dress uniform is covered within the fire department contract and is paid out of the fire department budget. Trustee Fleshman suggested the police department Class A dress uniforms be handled the same. Vice-Chairman Alex reviewed the fire department contract and then read the specific clothing/uniforms the fire department contract includes. In Vice-Chairman Alex's reading, one (1) Class A dress uniform is listed in the fire contract. Vice-Chairman Alex closed by saying the language within the current FOP contract needs reviewed, then if it is determined that the Class A dress uniform is not included and the FOP wants Class A dress uniforms this topic can be negotiated at the appropriate time.

Board discussed 2018 expenses to ensure all departments are staying within their departmental budgets. Vice-Chairman Alex suggested a budget process should be established.

Chairman Horn asked the Chief Smith who from the Township attended the funeral service/procession of the two Westerville police officers. The chief indicated that him and two officers each driving a cruiser were in the procession. Fleshman indicated he attended the service as well.
