Minutes of Franklin Township, Franklin County, Ohio

Special Meeting

Held at 2193 Frank Road

July 7, 2023

The Chair (Mr. Fleshman) called the Franklin Township Board of Trustees Special Meeting to order at approximately 9:00 A.M.

The Chair (Mr. Fleshman) led the opening prayer.

Trustee Horn led in the Pledge of Allegiance.

New Business:

Administrator Mazer introduced guest speakers Craig Moncrief, an attorney representing the future owner of 771 Harrisburg Pike, Mark Gray of Mark Gray Enterprises.

Mr. Moncrief and Mr. Gray provided a visual presentation to the Board of Trustees, including ground-level and ariel photos of the existing parcels and graphics displaying future redevelopment and landscaping.

Mr. Moncrief explained that they would present this information to the Board of Zoning Appeals (B.Z.A.) on July 17, 2023, hoping for a letter of support from Franklin Township.

The Chair (Mr. Fleshman) asked Mr. Gray to explain his security plans for the site. Mr. Gray explained that the site will have 24/7 security and exterior lighting. The Chair (Mr. Fleshman) agreed that exterior lighting is essential if the lighting does not shine in the direction of any adjacent residential property located near this property.

Trustee Horn asked Mr. Moncrief and Mr. Gray to clarify their redevelopment plans.

Mr. Gray explained that he plans to use the site for industrial storage, such as containers and construction equipment.

The Assistant Fiscal Officer asked Mr. Gray about the child daycare center on this property if he intended to leave them operating, and if so, what measures he would take to protect the children from the business and any noise caused by the trucks and equipment. Mr. Gray said he would takk

with the daycare and do whatever is necessary to provide a barrier between the storage area and the daycare.

The Chair (Mr. Fleshman) asked Mr. Gray if he planned to keep this property in Franklin Township or if he wanted to annex it into the City of Columbus. Mr. Gray said he plans to keep this property in the Township.

The Chair (Mr. Fleshman) made a motion for a letter of support in the redevelopment of 771 Harrisburg Pike by Mark Gray Enterprises.
