

**RESOLUTION NO. 20-111**

**A RESOLUTION LEVYING A \$5 MOTOR VEHICLE REGISTRATION TAX  
ON ALL VEHICLES REGISTERED IN THE UNINCORPORATED AREAS OF  
FRANKLIN TOWNSHIP, FRANKLIN COUNTY, OHIO,  
PURSUANT TO O.R.C. 4504.181**

**PREAMBLE**

**WHEREAS**, the Franklin Township Board of Trustees (the “Board”) has found that an additional annual \$5 motor vehicle registration tax on motor vehicles registered in the unincorporated areas of Franklin Township (the “Township”) would benefit the construction and maintenance of Township roads; and

**WHEREAS**, pursuant to Section 4504.181 of the Ohio Revised Code, the Board is authorized to levy an additional annual \$5 motor vehicle registration tax; and

**WHEREAS**, the Board held public hearings on this resolution on May 26, 2020, at 3:00 P.M. via conference call number 1-301-715-8592, Meeting ID: 861 6013 2285 Password: 093408 at and May 29, 2020 at 3:00 P.M. via conference call number 1-646-876-9923 Meeting ID: 875 5979 8006 Password: 217266; and

**WHEREAS**, notice of those public hearings was published in The Columbus Dispatch on May 9, 2020 and May 16, 2020; and

**WHEREAS**, it is in the best interests of the Township and its residents to proceed under Section 4504.181 of the Ohio Revised Code in order to collect an additional \$5 motor vehicle registration tax to be used for the authorized purposes contained in Section 4504.181 of the Ohio Revised Code.

**RESOLUTION**

**NOW THEREFORE**, be it resolved by the Board of Trustees of Franklin Township, Franklin County, Ohio, (the “Board”) that the following Resolution be, and it hereby is, adopted:


**Section 1.** The Board hereby adopts an annual \$5 motor vehicle registration tax to be levied on all vehicles registered in the unincorporated areas of the Township pursuant to Section 4504.181 of the Ohio Revised Code, and such funds will be used for authorized purposes contained in Section 4504.181 of the Ohio Revised Code.

**Section 2.** This Board finds and determines that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in open meetings of this Board, and that all deliberations of this Board that resulted in formal actions were taken in meetings open to the public, in compliance with all legal requirements, including but not limited to, Ohio Revised Code Section 121.22, except as otherwise permitted thereby.


This resolution shall take effect thirty days following the adoption of this resolution.


