

RESOLUTION 2020-133

A RESOLUTION TO ADOPT THE TAX BUDGET FOR FRANKLIN TOWNSHIP, OHIO FOR THE YEAR BEGINNING JANUARY 1, 2021 AND TO SUBMIT THE SAME TO THE FRANKLIN COUNTY BUDGET COMMISSION

WHEREAS, The Tax Budget for 2021 has been prepared as required by Section 5705.28, Revised Code; and

WHEREAS, Two copies of the tax budget were on file in the office of the fiscal officer for public inspection on June 29, 2020, and was available for public inspection as required by Section 5705.30, Revised Code; and

WHEREAS, A public hearing was held by the FRANKLIN TOWNSHIP BOARD OF TRUSTEES, FRANKLIN COUNTY, OH, on July 9, 2020 at 6:00 p.m. via Zoom conference call; and

NOW THEREFORE, BE IT RESOLVED BY THE TRUSTEES OF FRANKLIN TOWNSHIP, FRANKLIN COUNTY, OHIO, THAT:

Section 1. The Tax Budget for Franklin Township, Franklin County, OH, for the fiscal year beginning January 1, 2021 attached hereto as Attachment A and incorporated by reference, be and is hereby adopted by the BOARD OF TRUSTEES.

Section 2. The Fiscal Officer be and hereby is authorized and directed to certify a copy of said budget and a copy of this Resolution and to transmit the same to the Franklin County Budget Commission on or before July 20, 2020.

Section 3. It is hereby found and determined that all formal actions of this Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that any and all deliberations of this Board that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.

WHEREFORE, this Resolution shall take effect and shall be in force immediately upon passage by Board.
