Employee Dishonesty and Faithful Performance of Duty Coverage

Under O.R.C. 3.061, an "employee dishonesty and faithful performance of duty policy," such as a coverage document issued by a joint self-insurance pool, like OTARMA, can protect a township from financial or property loss in lieu of giving a surety bond for public officials that are required to be bonded under O.R.C. 3.061.

OTARMA'S Governmental Property Agreement is an advantage over surety bonds, as it will provide coverage if there is a loss of funds while the public officials are performing their duties in office. With a surety bond, public officials' private assets are pursued by the bonding company to satisfy any payment of loss.

If an OTARMA Member elects employee dishonesty and faithful performance of duty coverage provided under the OTARMA Governmental Property Agreement, the OTARMA Member must, pursuant to O.R.C. 3.061, pass a resolution to authorize OTARMA's coverage document as a, "employee dishonesty and faithful performance of duty policy," in lieu of surety bonds, for various positions within the township, including, but not limited to, the following: Trustee, Fiscal Officer, Assistant Fiscal Officers, Deputy Fiscal Officer, Zoning Inspector, Assistant Zoning Inspector, Road Superintendent, Constable, Fire Chief, Police Chief and Administrator.
