Cat5 Extender with mouse will be needed from NVR to monitor. Install Battery Back Up. We recommend a battery backup at the NVR in the event of a power loss.

Office building has drop ceiling throughout for cable runs. Police building cabling will be ran inside along the wall/ceiling to designated locations. wire molding is priced out to cover cabling.

x4 Ubiquity Point to Point Radios and x2 full gig 4 Port POE Switch from the main Office Building to the Police Building and Salt Building.
