

Resolution 2022-079

A Resolution Approving Obligations Authorized by the Township Administrator

The Board of Trustee of Franklin Township, Franklin County, Ohio met in person in a Regular Session at 12:00p.m. on July 14, 2022 and the following trustees and the following Resolution was adopted:

WHEREAS, the board of township trustees, in Resolution 2021-130, authorized the Township Administrator to approve/incur obligations of ten thousand dollars (\$10,000) or less on behalf of the township in accordance with Section 507.11 of the Ohio Revised Code; and,

WHEREAS, pursuant to the provisions of Section 507.11(A) of the Ohio Revised Code, the obligations approval/incurred by the Township Administrator must be subsequently approved by the adoption of a formal resolution of the board of township trustees.



SECTION 1, *The obligations authorized/incurred by the Township Administrator as presented in Exhibit A attached hereto are hereby approved.*



SECTION 3, *That this Resolution shall be in force and effect immediately upon its adoption.*


