BE IT RESOLVED by the Board of Trustees of Franklin Township, Franklin County, Ohio that the Board approves and endorses the recommendation of Fire Chief Arnold to hire Andrew Schmidt, effective August 16, 2023, as a new firefighter at the level of Firefighter I, at an annual salary of \$52,815.87, per the Local 1441 collective bargaining agreement.


BE IT FURTHER RESOLVED that this Resolution shall be in full force and effect immediately upon its adoption.


