

**Resolution 2024-019**

**A Resolution Concerning the Intent of the Village of Valleyview to Adjust the Boundaries of Franklin Township.**

The Board of Trustees of Franklin Township, Franklin County, Ohio, met in person in a Special Meeting at 9:00 a.m. on Thursday, March 14, 2024. The trustee marked below made a motion for the adoption of the following Resolution:

**WHEREAS**, Franklin Township is aware of the intent of the Village of Valleyview to petition the Franklin County Board of County Commissioners pursuant to Section 503.07, Ohio Revised Code for an order to erect a new township to be named "Valleyview Township" or a name of the Commissioners' choosing, to change the boundaries of Franklin Township to remove the portion of Franklin Township which is included within the limits of the Village of Valleyview, and to adjust the boundary lines of the new township to coincide with the boundary lines of the Village of Valleyview; and

**WHEREAS**, on March 23, 2023, the Franklin Township Board of Trustees received notice pursuant to Section 503.07(B), Ohio Revised Code, of the Village of Valleyview's intent to hold a vote on an ordinance to change township lines affecting Franklin Township.

**WHEREAS**, Franklin Township did not oppose the Village of Valleyview's efforts to erect a new township to be named "Valleyview Township" or a name of the Commissioners' choosing, to change the boundaries of Franklin Township to remove the portion of Franklin Township which is included within the limits of the Village of Valleyview, and to adjust the boundary lines of the new township to coincide with the boundary lines of the Village of Valleyview; now, therefore,

**BE IT RESOLVED BY THE BOARD OF TRUSTEES OF FRANKLIN TOWNSHIP, OHIO:**

That Franklin Township does not oppose the Village of Valleyview's petition to the Franklin County Board of County Commissioners pursuant to Section 503.07, Ohio Revised Code for an order to erect a new township to be named "Valleyview Township" or a name of the Commissioners' choosing, to change the boundaries of Franklin Township to remove the portion of Franklin Township which is included within the limits of the Village of Valleyview, and to adjust the boundary lines of the new township to coincide with the boundary lines of the Village of Valleyview.

**BE IT FURTHER RESOLVED** that all formal actions of this Board concerning and relating to the adoption of this Resolution were passed in an open meeting of this Board and that all deliberations of this Board and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

**BE IT FURTHER RESOLVED** that this Resolution shall be declared an emergency upon its adoption.
