A Resolution Approving the Acceptance of Salary Reimbursement from the Ohio Bureau of Workers Compensation (OBWC)

BE IT RESOLVED, by the Board of Trustees of Franklin Township, Franklin County, Ohio, that the Board approves and authorizes the acceptance of a check in the amount of \$10,584.29 from the Ohio Bureau of Worker's Compensation (OBWC) regarding salary reimbursement to the Township for wages paid to an injured employee. BE IT FURTHER RESOLVED, the reimbursement amount is calculated at 72% of the injured employees regular bi-weekly salary or wages.

BE IT FURTHER RESOLVED that all formal actions of this Board concerning and relating to this Resolution were passed in an open meeting of the Board, and that all deliberations of this Board and any of its committees that resulted in such formal action were in a meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.



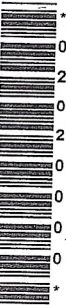
