Garden Rules

Personal Plot Requirements

- Plots must be maintained throughout the growing season of May through October.
- Plots must be cleaned and started no later than June 1st.
- At the end of the gardening season properly dispose of all dead plants and nonplant materials (string, wire, wood, metal, plastic, etc.) by November 1st.
- Notify garden leadership if you are no longer able to maintain your personal plot (either permanently or temporarily).
- If your personal plot becomes unkempt, you will be given 1 week notice to clean it up. After that time, your plot can be reassigned.
- Commit to following organic gardening principles and not using chemicals (fertilizers, pesticides, etc.) in or near the gardens.
- Keep the garden clean and free of all trash and litter.
- Dispose of weeds and diseased plants properly by placing them in the designated trash bins in the alley located on the east side of the garden.
- Plant tall plants and vines in places where they will not interfere with adjoining areas.
- Do not pick anything from another person's personal plot without their approval.

Collective Plots Requirements

- Keep the garden clean and free of all trash and litter.
- Commit to following organic gardening principles and will not use chemicals (fertilizers, pesticides, etc.) in or near the gardens.
- Dispose of weeds and diseased plants properly by placing them in the designated trash bins in the alley located on the east side of the garden.
- Do not pick anything from the collective gardens without receiving prior approval.

Requirements for All Gardeners

- Respect other gardeners, and refrain from using abusive language and/or discriminating against others.
- Work to keep the garden a happy, secure, and enjoyable place where all participants can garden and socialize peacefully in a neighborly manner.
- Be considerate of the garden's neighbors and act in a manner to preserve their quality of life.
- Do not ask neighbors to provide use of telephones (except in emergencies) or restrooms.

Health and Safety Requirements

- Regular gardening hours are between 7 AM to 10:00 PM, 7 days a week.
- Please consider gardening in pairs or keeping a cell phone nearby.
- Report theft, vandalism and unusual activities to the garden leaders and non-emergency police.

- Fireworks and fires are not permitted at the garden.
- Personal plots and collective garden areas may not be used to grow illegal plants.
- Smoking and consumption of alcohol are not permitted at the garden.
- Children are welcome at the garden when accompanied and supervised by an adult.
- Loud music is prohibited. Please listen to music using headphones to help preserve the tranquility in the garden and for neighbors.
- Keep pets out of personal plots and collective garden areas. Keep pets leashed, under your control at all times and clean up after pets.

Gardener's Liability Waiver and Indemnification

The undersigned, in consideration for the Franklin Township, Franklin County, Ohio, Broadlawn Community Garden, allowing him/her/it to enter the Licensed Premises solely for the purpose of conducting gardening activities, does hereby consent and agree to the following:

The undersigned hereby waives and releases the Franklin Township, Franklin County, Ohio, all of its departments and divisions and all of its employees, agents or other representatives against any monetary ward, both compensatory and punitive, or equitable relief by a judge or jury that may result from damages or loss of persons or property sustained while entering upon and/or conducting gardening related activities at Licensed Premises.

In no event shall the undersigned or any of his/her heirs assigns, agents or any other individual or entity acting on behalf of the undersigned be considered, nor shall he/she hold himself/herself out to be, an officer, employee, agent or other representative of the Franklin Township, Franklin County, Ohio.
