Repayment Plan pursuant to R.C. 9.24(B)(2)

REPAYMENT PLAN

This Repayment Plan is between Franklin Township, Franklin County, Ohio and Robyn Watkins and the Ohio Attorney General;

RECITALS

WHEREAS, on February 6, 2024, the Auditor of State certified a finding for recovery in a special audit that was conducted for the audit period of 2018 through 2022 in the amount of \$8,567.00 against Robyn Watkins, CRN 21594835 and

WHEREAS, as a result, a Finding for Recovery was issued against Robyn Watkins in the total amount of \$8,567.00.

WHEREAS, Robyn Watkins wishes to fully resolve the finding by entering into a Repayment Plan, in accordance with R.C. 9.24(B)(2);

NOW THEREFORE, in consideration of the mutual promises, covenants, and undertakings set forth below, and other good and valuable consideration, the receipt and sufficiency of which Robyn Watkins hereby acknowledges and agrees as follows:

- A. <u>Terms of Repayment Plan</u>. Robyn Watkins shall pay the sum of \$175.00 in bi-weekly payments beginning September 3, 2024 and continuing to September 3, 2026, in total the sum of \$8,567.00.
- B. Franklin Township agrees to accept the payments set forth in paragraph A above and any tax refund offsets as described in paragraph C below in satisfaction of the CRN 21594835
- C. The Ohio Attorney General's Office shall notify the Auditor of State in the next quarterly statutory report following the date of execution of the repayment plan that the Finding for Recovery, as against Robyn Watkins, is resolved.
- D. In the event that Robyn Watkins defaults under this agreement and hereby consents to judgment for the full amount of the findings, \$8,567.00, in any court of competent jurisdiction, and understands that the Franklin Township may exercise any remedy available at law to collect that amount.
- E. This Repayment Plan may be executed in multiple counterparts and signature pages may be exchanged by facsimile or other method of reproduction.

- F. This Repayment Plan is executed by individuals with requisite authority to bind the parties to the terms hereof.
- G. This Repayment Plan constitutes the complete agreement with Robyn Watkins and cannot be modified except in writing with the approval of both parties.
- H. Robyn Watkins had access to counsel of its choosing and the rule of construction that any ambiguity shall be construed against the drafter shall not apply.
- I. This Payment Plan resolves only civil liability for the Finding for Recovery issued against Robyn Watkins, arising from the audit of Franklin Township for 2018 through 2022 and does not resolve any other liability, including, but not limited to, criminal liability or tax liability.
- J. This Repayment Plan is effective on full execution by Robyn Watkins.
