A Resolution Authorizing an Agreement Between Franklin Township and Express Wash Holdco LLC dba Moo-Moo Car Wash for Washing of Eleven Police Cruisers

The Board of Trustee of Franklin Township, Franklin County, Ohio, met in person in a Regular Meeting at 12:00p.m. on Thursday, March 6, 2025, at 2193 Frank Road, Columbus, Ohio. The trustee marked below made a motion for the adoption of the following resolution:

BE IT RESOLVED, the Board of Trustees of Franklin Township, Franklin County, Ohio, approves and authorizes an agreement with Express Wash Holdco, LLC, dba as Moo-Moo Cash Wash for the purpose of washing eleven (11) police officer cruisers (non-management) in an amount not to exceed \$2,640.00 for twelve consecutive months.

BE IT FURTHER RESOLVED that the car wash billing will be established on a month-to-month basis for eleven (11) cruisers \$20 each/month for 1 year with the basis and ability for the township to amend and/or cancel this agreement at any time.

BE FURTHER RESOLVED that all formal actions of this Board concerning and relating to this Resolution were passed in an open meeting of the Board, and that all deliberations of the Board and any of its committees that resulted in such formal action were in a meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code


BE IT FURTHER RESOLVED that this Resolution shall be declared an emergency and be in full force and effective immediately upon its adoption.
