**BE IT RESOLVED** that the Board of Trustees of Franklin Township, Franklin County, Ohio approves and authorizes the removal of trees that were damaged during a recent storm at Union Cemetery on Frank Road (property of the Township).

**BE IT FURTHER RESOLVED**, The lowest and best bid was accepted from Peterman Brothers Tree Service for the removal of the trees in the amount of \$6,087.00. The insurance company will submit to the Township a payment of \$6,087.00 for the removal of trees. (See Exhibit A)

**BE IT FURTHER RESOLVED** that there is an additional cost of \$690.00 for the removal of the tree stumps. This expense is not covered by the insurance claim and is a cost to the Township.

**BE IT FURTHER RESOLVED** that all formal actions of this Board concerning and relating to this Resolution were passed in an open meeting of the Board, and that all deliberations of the Board and any of its committees that resulted in such formal action were in a meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code


