BE IT RESOLVED that the Board of Trustees of Franklin Township, Franklin County, Ohio approves and authorizes the repair and replacement of fencing caused by fallen trees at Union Cemetery due to a storm.

BE IT FURTHER RESOLVED that the lowest and best bid was accepted by the Bowden Fence Company in the amount \$14,206.00. The Township's insurance company will submit to the Township a payment of \$11,706.00 for the repair and replacement of fencing. (See Exhibit A)

BE IT FURTHER RESOLVED that the township will be responsible for the insurance deductible of \$2,500.00.

BE IT FURTHER RESOLVED that all formal actions of this Board concerning and relating to this Resolution were passed in an open meeting of the Board, and that all deliberations of the Board and any of its committees that resulted in such formal action were in a meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code

BE IT FURTHER RESOLVED that this Resolution shall be declared an emergency and be in full force and effective immediately upon its adoption.


