SECTION 2: All formal actions of this Board concerning and relating to the adoption of this Resolution were conducted in an open meeting of the Board, and all deliberations of the Board and any of its committees that resulted in such formal action were conducted in meetings open to the public, in full compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3: That this Resolution shall be declared an emergency and will be in full force effective immediately upon its adoption.




