A RESOLUTION ACCEPTING AND ENROLLING IN A SECURITY OPERATIONS CENTER SERVICE (COS)

The Board of Trustees of Franklin Township, Franklin County, Ohio, met in person in a Special Meeting at 10:00a.m. on Thursday, January 29, 2026, at 2193 Frank Road, Columbus, Ohio. The Trustee marked below made a motion for the adoption of the following resolution:

WHEREAS Franklin Township, Franklin County, Ohio, relies on information technology systems and electronic devices to conduct Township operations and to maintain sensitive and confidential information; and

WHEREAS Franklin Township recently experienced a cybersecurity breach, highlighting the need to strengthen and enhance the Township's cybersecurity posture; and

WHEREAS, the Township's information technology management provider, Revolution Group, has evaluated the Township's current cybersecurity environment and has recommended enrollment in a Security Operations Center (SOC) service to provide continuous monitoring, threat detection, and incident response capabilities; and

WHEREAS, Revolution Group has provided a quote for SOC services at a cost of \$15.00 per month per device, and Franklin Township currently maintains seventeen (17) devices within its inventory; and (*Exhibit A*)

WHEREAS the total cost for said SOC services is \$255.00 per month, or \$3,060.00 annually, subject to changes in the number of devices enrolled; and funds are appropriated for such expenditure.

WHEREAS the Franklin Township Board of Trustees finds that enrolling in a Security Operations Center service is necessary and in the best interest of the Township to enhance cybersecurity, protect Township data, and reduce the risk of future cybersecurity incidents.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Franklin Township, Franklin County, Ohio, that:

The quote for Security Operations Center (SOC) services, as recommended by Revolution Group, is hereby accepted.

The Franklin Township Board of Trustees hereby authorizes the enrollment of the Township's seventeen (17) devices in the SOC service at a cost of \$15.00 per device per month.

BE IT FURTHER RESOLVED that all formal actions of this Board concerning and relating to the adoption of this Resolution were passed in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

BE IT FURTHER RESOLVED, this resolution is declared an emergency and shall take effect immediately upon its adoption.
