A RESOLUTION AUTHORIZING THE ERECTION OF AN ACCESSIBLE PARKING SIGN AT 1843 RANSBURG AVENUE

The Board of Trustee of Franklin Township, Franklin County, Ohio, met in person in a Regular Meeting at 6:00 p.m. on Thursday, March 5th, 2026, at 2193 Frank Road, Columbus, Ohio. The Trustee marked below made a motion for the adoption of the following resolution: .

WHEREAS, the Board of Trustees of Franklin Township, Franklin County, acting pursuant to the authority granted under the laws of the State of Ohio; and

WHEREAS, the property located at 1843 Ransburg Avenue, Columbus 43223 lies within Franklin Township; and

WHEREAS, Ohio Revised Code Section 4511.69 requires political subdivisions to properly designate accessible parking spaces with an elevated sign displaying the international symbol of access, mounted not less than five (5) feet above the ground, and indicating the applicable penalty for unauthorized use; and

WHEREAS, Ohio Revised Code Section 9.54 requires that signage using the international symbol of access include the term "Accessible" rather than "Handicapped" or "Disabled"; and

WHEREAS, the Board of Trustees finds it necessary and appropriate to designate and properly mark an accessible parking space at 1843 Ransburg Avenue for the protection of public health, safety, and welfare and to ensure compliance with state law;

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Franklin Township, Franklin County, Ohio, that:

SECTION 1. Authorization

The Township Administrator and/or Service Department is hereby authorized and directed to procure and erect one (1) accessible parking sign at 1843 Ransburg Avenue, Columbus, Ohio 43223.

The sign shall:

1. Display the international symbol of access;
2. Be mounted on a fixed or movable post with the bottom of the sign not less than five (5) feet above the ground;
3. Include language stating the statutory fine for unauthorized parking in an accessible space as required by Ohio Revised Code §4511.69; and
4. Use the term "Accessible Parking" in compliance with Ohio Revised Code §9.54.

SECTION 2. Enforcement

The Franklin Township Police Department and any other authorized law enforcement agency are authorized to enforce violations related to unauthorized parking in the designated accessible space in accordance with Ohio law.

SECTION 3. Funding

The cost of purchasing, installing, and maintaining the sign shall be paid from the appropriate Township fund.

BE IT FURTHER RESOLVED that all formal actions of this Board concerning and relating to this Resolution were passed in an open meeting of the Board, and that all deliberations of this Board and any of its committees that resulted in such formal action were in a meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

BE IT FURTHER RESOLVED that this Resolution shall be declared an emergency and be in full force and effective immediately upon its adoption.


