A RESOLUTION AUTHORIZING THE APPROVAL OF A QUOTE FROM PARR PUBLIC SAFETY EQUIPMENT, INC. FOR THE UPDATE OF POLICE CRUISER DESIGN GRAPHICS

The Board of Trustee of Franklin Township, Franklin County, Ohio, met in person in a Regular Meeting at 6:00 p.m. on Thursday, April 16th, 2026, at 2193 Frank Road, Columbus, Ohio. The Trustee marked below made a motion for the adoption of the following resolution:

WHEREAS, the Board of Township Trustees finds it necessary to update the design graphics on township police cruisers for purposes of visibility, identification, and public safety; and

WHEREAS, the Township has received a quote from Parr Public Safety Equipment, Inc. for such services and has determined that the quoted services are in the best interest of the Township and are reasonably priced;

NOW, THEREFORE, BE IT RESOLVED by the Board of Township Trustees of Franklin Township, Franklin County, Ohio that the quote submitted by Parr Public Safety Equipment, Inc. for the updating of design graphics on township police cruisers 302, 303, 305, 306, 307 and 311 is hereby accepted and approved.

BE IT FURTHER RESOLVED The total cost for such services shall not exceed One Thousand One Hundred Ninety Dollars (\$1,190.00) per cruiser. The Board certifies that sufficient funds are available and properly appropriated from the appropriate township fund for this expenditure. The Chief of Police is hereby authorized to execute all necessary documents to implement this project and to approve payment in accordance with this Resolution.

BE IT FURTHER RESOLVED that this Resolution shall be in full force and effect immediately upon its adoption.


