

Approving an Agreement to Extend Negotiations Between Franklin Township and Fraternal Order of Police Lodge #9

The Board of Trustee of Franklin Township, Franklin County, Ohio, met in person in a Regular Meeting at 3:00 p.m. on Wednesday, June 24th, 2026, at 2193 Frank Road, Columbus, Ohio. The Trustee marked below made a motion for the adoption of the following resolution:

WHEREAS, the Franklin Township Board of Trustees and the Fraternal Order of Police, Lodge #9, representing the members of the Franklin Township Police Department, are currently engaged in collective bargaining negotiations for current contract dated July 1, 2023 through June 30, 2026 ; and

WHEREAS the parties have mutually agreed to waive certain provisions of Ohio Revised Code Section 4117.14(G)(11) in SERB Case Nos. 2026-MED-03-0311 and 2026-MED-03-0312. (see exhibit)

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Franklin Township, Franklin County, Ohio, that:

Section 1. The Board of Trustees approves the agreement between Franklin Township and the Fraternal Order of Police, Lodge #9, to waive the provisions of Ohio Revised Code Section 4117.14(G)(11) in SERB Case Nos. 2026-MED-03-0311 and 2026-MED-03-0312.

Section 2. The parties agree that an award for wages and other matters with cost implications may be made retroactive to July 1, 2026.

Section 3. The current collective bargaining agreement (July 1, 2023 – June 30, 2026) shall remain in full force and effect until a successor agreement is executed by the parties.

SECTION 4. That all formal actions of this Board concerning and relating to this Resolution were passed in an open meeting of the Board, and that all deliberations of this Board and any of its committees that resulted in such formal action were in a meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 5. That this Resolution shall be in full force and effective immediately upon its adoption.

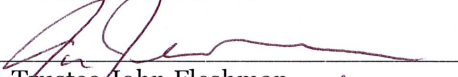

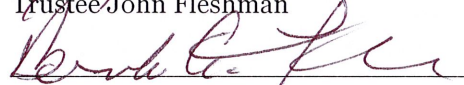

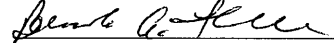
