

Resolution 2026-133

A Resolution to Adopt the Annual Road District Tax Millage for Franklin Township, Franklin County, Ohio, for the Year beginning January 1, 2027, and to Submit the Same to the Franklin County Budget Commission

The Board of Trustees of Franklin Township, Franklin County, Ohio, met in person in a Special Meeting at 12:00 p.m. on Friday, July 24, 2026, at 2193 Frank Road, Columbus, Ohio. The trustee marked below made a motion for the adoption of the following Resolution:

WHEREAS, pursuant to Resolution No. 2020-108, the Board of Township Trustees of Franklin Township, Franklin County, Ohio, established the Franklin Township Road District, consisting of all unincorporated territory within Franklin Township; and

WHEREAS the Road District is authorized to receive and utilize an additional inside tax levy of 2.35 mills for the construction, reconstruction, maintenance, and repair of township roads, bridges, and related roadway infrastructure within the Road District; and

WHEREAS, the Board of Township Trustees has determined that the levy of the available 2.35 mills of inside millage is necessary to provide sufficient revenues for the operation and maintenance of the Franklin Township Road District during the tax year beginning January 1, 2027; and

WHEREAS the Franklin County Budget Commission requires the Township to certify the annual tax millage requested for the Road District as part of the Township's 2027 Tax Budget. (Resolution 2026-131)

NOW, THEREFORE, BE IT RESOLVED by the Board of Township Trustees of Franklin Township, Franklin County, Ohio, that:

Section 1. The Board hereby adopts and requests the levy of the available 2.35 mills of inside tax millage for the Franklin Township Road District for the tax year beginning January 1, 2027, for collection in calendar year 2027, or as otherwise provided by law.

Section 2. The Board finds that the revenues generated from this inside millage are necessary for the operation, maintenance, construction, reconstruction, and repair of township roads, bridges, and related roadway infrastructure within the Franklin Township Road District.

Section 3. The administrative staff is hereby authorized and directed to include this Road District millage request as part of the Township's 2027 Tax Budget and to certify and submit all necessary documentation to the Franklin County Budget Commission and any other appropriate county officials as required by law.

Section 4. It is found and determined that all formal actions of this Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and any committees thereof that resulted in such formal action were conducted in meetings open to the public in compliance with all applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 5. This Resolution shall take effect and be in force immediately upon its adoption.

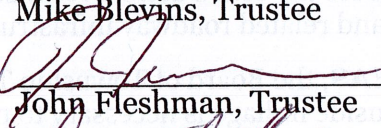

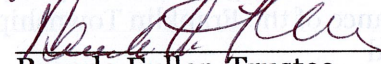
